- Need to identify the local SMEs and companies as well as public services and administrations to support them
- How can this be improved in Slovakia?

# Industrial Panelists

- Experience from national LT suppliers, LT developers or language data producers
- National market's offering and the need of language-centric AI in terms of language data and LLMs for growth and competitiveness at a European level
- Can productivity be improved?
- Can their markets be expanded?
- Do their companies rely on larger international players to evolve?

# Private sector data holders

- Experience on data holding or production: have they successfully monetised their data?
- Needs and concerns, and the complexity to benefit from a local data market
- Do data providers know how to capitalise on the value of their data?
- Success cases

# Public sector representatives

- Experience unveils language technology and multilingual services' needs
- Need for an involvement of administrations and governments in the development of LT
- Need to use LT with the support of local LT/AI companies: do they need help to understand the advantages?
- Private sector stakeholders can provide language data and/or LT
